Member Theressa Arrick-Kruger made a motion to approve the agenda. Member Jean Roth seconded the motion. The motion passed unanimously.

Executive Director Report. Steve Sallee provided this linked report and verbal updates. Karlyn will schedule a July Personnel Committee meeting. Steve confirmed with Gary Lee at MSBA that virtual school board meetings are still acceptable. The October board meeting coincides with the MSC conference, so cancelling that meeting is tentatively planned. Karlyn will register everyone interested in attending the MSC conference. SSC pays for lodging and mileage. The 2022 MSC conference is being planned to be held in October again, rather than July, when these were previously held. The Geacom contract will likely be ready for approval in August. Geacom has been working with Austin public schools, and the Austin school district has given great reviews on the work Geacom is doing. CTE funding that supports our Career Navigators' salaries was left out of the final K12 bill. SSC is working to regain funding through other avenues. Steve briefly discussed the possibility of a state shutdown and potential ramifications to RCE staff.

There are no Program Manager updates this month.

Dale Walston provided the School Pool Renewal Progress Report. All current groups renewed or are in the process of renewing, except one. There is one large group and two small groups working to flip into the Jan 1 pool. Annie with Holmes Murphy is working fervently to recruit new prospects, and several meetings have been scheduled for this week and next week.
