**MSC Statewide Collaboration** -Ann Kilzer, Executive Director of MN Service Coops, joined via zoom and shared an overview and updates about the collaborative work being done at the statewide level. This includes developing a stronger partnership with MDE, legislative advocacy and the development of collective voice, strong student academic programming, and the growth and sustainability of MSC.

**Executive Director Report** -Steve Sallee shared updates about the executive director evaluation tool and timeline and also shared a summary of recent MHC and Medica meetings. In June, Steve and Amy will be meeting with each staff member to check in. Jeff Aamot and Kari Kubicek will be at the June meeting to update the board on RCE and Educational Services. Finally, he shared an update on the status of the state CTE funding.

**Program Updates** -Amy Grover shared updates from the written report, highlighting that Caledonia Schools and Zumbrota-Mazeppa Schools hosted Althing student health events at their districts, which were the first in our region! Other events being planned include an ALICE Training at Cannon Falls Schools on August 3-4, and the IEA/SSC Facilities Management Town Hall on June 14. Finally, we shared that 900+ students in grades 3-5 convened at the 35th Annual Young Authors, Young Artists Conference at RCTC in Rochester on May 17-19 and had a fantastic experience.
